


In remembrance!

Wednesday May 9th 2001

will never ever forget this day. I still wake up at night and early in the morning and remember the afternoon rain, the match itself, the linesman's flag, the poor officiating, the tear gas, the images of people jumping from great heights to escape the tear gas, the confusion and the stampede, the injured and the dead, the club colours draped on the dead, the living and the hope. The hope came from one supporter alive but injured at the Military hospital. As I visited the wounded he called out to me and told me not to worry...he told me that but for the officiating things would have been different. He was concerned about the club and not his terrible injuries. He wanted to get out so that he could watch our next match. He believed the development and direction was right. I was astounded and could only keep my quiet!

Sunday May 13th 2001

Last Sunday afternoon I attended a special inter faith service on the forecourt of the state House. The service was organised by the Government to honour and remember the dead. The event was both poignant and emotional for me and when I had to give a brief speech I could hardly contain my feelings!

A brief summary of my speech is outlined as follows;

"I am truly humbled to be here today. In making this short speech I would like to start by quoting Ecclesiastics 9 verse17.

"No one can anticipate the time of disaster. Like a fish caught in a cruel net or birds caught in a trap, so are humans caught at a time of calamity when it suddenly falls upon them. [Ecclesiastics 9 verse17]

"This is not a personal tragedy for Hearts or Kotoko: it is a national disaster for all of us. That is why the nation mourns and that is why the global football community is grieving and that is why we as individuals can only weep more loudly.

"The death of 126 young men, women and children in circumstances, which could and should have been avoided, is particularly personal and painful for me and for all the country. It is an unimagined tragedy, unsurpassed at the international level. The trauma of having to save the dead from the crush will haunt me forever. I still wake in the morning haunted by the events of that fateful Wednesday night. I carried over twenty bodies and never for one moment considered whether they were Kotoko supporters or Hearts supporters. I only knew them to be Ghanaian football supporters who may well be alive. I knew I had to try my best to save them. We all did what we could in our own way on that fateful night. Sadly it was not enough! But that does not diminish the tragedy. Lessons will have to be learnt to prevent such a dreadful event from ever happening again.

"Our thoughts are particularly with the families and friends. Those young men, women and children, Hearts and Kotoko supporters alike, are in our hearts and in our minds. Just as we do not know how the breath comes to the bones in the mother's womb, so we do not know the work of God who makes everything and takes everything away.

"The 126 young people are gone, but they will never be forgotten!!

Saturday May 12th 2001

Whilst watching the English FA Cup between Arsenal and Liverpool I received a visit from a young Hearts of Oak supporter. He is a member of the famous/infamous Chapter O. He had been at the stadium the night of the tragedy and he had seen us all working hand in hand to try and save the living and removing the dead. I later saw him at the Military Hospital the same night. This young man restored a lot of my faith in soccer. Even though some people should know better but don't this young man clearly did know better. It was a revelation to hear this young Hearts of Oak supporter exhibiting the kind of objectivity that will ensure that we all get through this. He recognised the need (as we do) for us to come together to make things work. He appeared to have the foresight to also recognise the need for the two teams to be seen to be working together in certain specific areas which would be of mutual benefit! He comported himself with class! He surprised me by indicating that he saw me carrying closer to 30 bodies and that he had visited some of the people saved to tell them of how they were saved. He also pointed out that one lady in particular had later died!

I watched Arsenal lose to Liverpool in the FA Cup final. This is a match they had won and only chose to lose! They outplayed Liverpool throughout the match and missed when it would have been easier to score.

My telephone did not stop ringing throughout the day. The need to be in touch with as many affected families as possible was key!

Friday May 11th 2001

This was a sad day. It was a day when the Muslims amongst the dead were buried. They were buried as was their tradition and the afternoon service was attended by His Excellency President J.A. Kuffuor and His Excellency Vice President Aliu Mahama. Also in attendance amongst others was Sheikh I. C, Quaye. There had been threats of disturbance but this was not to be.

The violent rampage by some of the youth in Nima was truly unfortunate. It now appears that it was orchestrated and not representative of the people in Nima at large! Their pain was understandable but the resulting violence was not. The politicising of their feelings was also truly wrong!


It was suggested that E.T. Mensah had been detained at the BNI headquarters on charges of incitement. The alleged acts of incitement in this manner are heinous and potentially destabilising. If they are true then E.T. Mensah has serious questions to answer. Kotoko

and Hearts are the two biggest clubs in the country and irresponsible comments and acts could easily confuse some supporters to act against their fellow Ghanaian.

In the current dispensation such actions are totally out of place. Given that it also occurred around the time of the anniversary "Kume Preko" deaths I would hope that this would have reminded the Attorney-General of the need for that matter not to be forgotten!

The Police

With the recent attacks on the Police I think that the time has come for us to look at ways of mending the broken bridges. They have become the easy and obvious target for many and in many ways this is understandable. The IGP has made it very clear of the fact that there will be no cover-up. We must give him the opportunity to handle the matter as professionally as I am sure he will do! I am sure that those responsible will be exposed. We do need to move on and there is a need for leaders to start encouraging a situation where it can be understood that the actions of a few policemen does not represent the entire Ghana Police Force. Whilst I cannot and will not condone the actions of those officers at the stadium that evening I think it important to note that we now have an excellent relationship with our force in Kumasi. We have not had the use of tear gas at the Kumasi Sports Stadium during my tenure and I am sure that will be maintained. For our supporters I continue to ask for your patience and understanding in these trying times! We will need to work together as Ghanaians for our total good and the Police are a part of this!

The Management of Sports in Ghana

I am so sad that this tragedy that we have now experienced may be the wake up call that is needed to put us on a programme to ensure that we move forward, never return to this situation and start achieving the targets that we as a nation are more than capable of achieving!

I fully sympathise with the Government's position although I have been a little concerned about the time it has taken to move forward. Clearly the legacy of E.T. Mensah has meant that it requires a great deal of strength and clarity of mind to take over this Ministry. The man has so violated this Ministry that it has to be fumigated to excess before we can truly move forward. It is not simply a question of replacing him as the Minister in charge. It goes further than this.

I believe that in the short term our sports should be handled in the following way. I believe there is a case for the establishment of a Sports Management Board that could be handled out of the Office of the President. This board would be tasked to manage, develop and run sports in Ghana. I believe that this board could be chaired from the office of the President and include a number of influential and knowledgeable people who would be tasked with a specific area of sports development. The members could be responsible for the following areas;

General policy, planning and finance, marketing and sponsorship, soccer, boxing and athletics, other sports, the youth, the development of facilities. I would include two lawyers and two accountants on this Board to be able to relook at matters left (like the various probes and monies spent on the feasibility plans into a stadium at Prampram etc!)

Although there are existing structures in place there is a need for them to be redirected from a different platform.

With respect to soccer the time has come for the Government to move. I believe that they should present a number of candidates (more than usual) to the Executive Council for consideration. Given the seriousness of our recent tragedy it is important that the back-

grounds of the people to be considered are taken into account. We shall all make our opinions known and would hope to be able to influence the final decision!

The Stadium Disaster Fund

On Sunday the Government launched a stadium disaster fund with the first monies being donated by Ghana Telecom. The Government also announced that all the families would be catered for by the Government and that their medical bills as well as the sum of ${\it c}_{2.5m}$ would be allocated to pay for the cost of funeral preparations!

Before the establishment of this fund we had been fully supportive of the Joy FM fund, which was set up immediately after the tragedy. Indeed we had asked a number of organisations who had come forward to donate directly to this fund. Collecting money for a worthy cause can sometimes be easy but the disbursement can be tricky! There is a need for major decisions to be made and these include the establishment of Trustees to ensure that whatever is agreed in terms of disbursement and management is carried out.

At this stage the Joy FM management will have to decide on what to do with their fund which apparently has raised close to $\phi 200,000,000$ (two hundred million cedis). There may be a strong case for incorporating their fund into that of the government's. There may also be a case for the Government appointing someone from Joy FM onto their own team, which will determine how the monies will be disbursed!

I wish to thank all the companies who have made the contributions they did. It shows the unique qualities that we have as Ghanaians. I have taken note and I hope that all do the same and realise that this is our future...our ability to work together in times of distress. Our culture dictates that we care for every human being and this has been proven to be the case!

In the meantime...

Public announcements from a section of Hearts supporters from Nima that they were going to attack me were unfortunate. I was not worried but only saddened because they simply DO NOT represent the views or feelings of the majority of their supporters. I have received great support from a large number of them and I was touched when some of the people I saved at the stadium (Hearts supporters) came to congratulate me later.

The violence that arose afterwards and the threats against me, Kotoko supporters in Legon etc. must be contained and stopped. Alhaji Grunsah once said that if people do not take care we could have a civil war, which could start from or between Hearts and Kotoko. An attack on Kotoko or me would be reciprocated before commonsense could take centre stage and peace must therefore be maintained before we reach this stage!

I am bitterly disappointed by the irresponsible statements made by some Hearts officials. Their public attempts to apportion blame are both distasteful and irresponsible. If their actions and statements succeed in motivating a small section of their supporters to take to arms then the consequences of the actions must be on their conscience forever! We at Kotoko harbour personal feelings which I believe would be counter productive and inflammatory to make public at this point and it is for this reason that we have and are keeping fairly silent on the specific behaviour of individual supporters before, on and after that infamous night! Maybe if either of them had had to participate in the body carrying of supporters and had been subject to the IMMEDIATE suffering and sight of blood and dying supporters they would have tempered the statements they made on air!

I found the advertisements in one of the dailies at the weekend in which specific donations were being made only for the use of the victims from Hearts very distasteful! I believe that it is also very disrespectful and divisive to all of the dead! We have made sure that all the companies, which came to us prior to Sunday made their commitments directly to the Joy FM stadium disaster fund irrespective of who, the direct beneficiaries are! The fund is supportive and not a profit centre for the families and therefore all affected would presumably benefit equally!

It is now time for the FA to move ahead. All over the world where we have had stadium related disasters the league has quickly resumed. I believe that this must be done with haste and that we must observe all the protocols that go with the remembrance and respect to the dead and their families that is culturally and internationally accepted. I would also ask the FA to consider a formulae of fund raising that would ensure that specific monies could be raised and allocated from our matches. I would like to propose that the FA and its affiliates including the Sports Council take a 50% reduction in their match fees. The clubs to support an educational and rehabilitation programme could then apportion the monies from this specifically for supporters at base

I understand that whilst in BNI custody E.T. Mensah said that he was going on hunger strike! He should be very careful because his keepers might just take him seriously and stop sending him any food. Mr Mensah must understand that there are those who blame him for a number of things and who have very little sympathy for him. From the Kume Preko deaths and including the mismanagement of Sports in Ghana, he has been blamed for most things! The fact that the stadium reports and the Gbadegbe reports were not acted on during his tenure also confirms for most people his responsibility for the sad state in which Ghana finds itself. His sacking of Coach Dossena when he had set us on course to qualify for the World Cup and his manipulation of players into believing that if they did not play for his club they would not be invited into the national team, is totally unforgivable. Indeed some of his assigns such as Afranie endorsed a programme which as Minister he could have stopped but didn't but which led to the current situation in which overaged players are used to win competitions etc! E.T. Mensah's legacy is what we are living with today!

International news agencies storm Accra

ntil last Wednesday Ghana was but a blip on most international news channels, but all that changed minutes after news of the disaster broke on local television and radio stations.

Indeed a couple of Ghanaians first heard the news from loved ones abroad who were shocked by a BBC breaking news report early Wednesday evening announcing that over 100 people had died at the stadium.

What was to follow next was both chaotic and orderly. In the midst of the chaos one news report filed by a one Catherine Nartey and posted on the CNN website mentioned that President Rawlings was visiting hospitals in the capital to see the victims. Obviously someone at CNN was still in the last century. CNN of course later did a live report with BBC correspondent Kweku Sakyi Addo and several strings with GTV's Francisca Ashietey-Odunton. BBC have not let Kweku off the hook and in hungry fashion sent down Ghanaian-born Ben Dotsei Malor to help 'excavate' any bit of news that was left for the nosy British Broadcasting Corporation.

Kweku reportedly had his phone ringing the whole day and at one time when CNN wanted him to go live he had to give up on them because his cell phone battery conked out! And CNN, like bloodhounds phoned an obviously uninformed Kofi Coomson for a rather hollow version of

As the week came to a close a two-man crew from M-NET's renowned investigative news programme Carte Blanche


arrived in town to do some news analysis of their own. Led by Producer Diana Lucas and anchor David Ampofo the team 'ran riot' in Accra over the weekend visiting the Military hospital morgue, the Accra Stadium, interviewing victims as well as talking to Herbert Mensah and Harry Zakkour.

One Ghanaian journalist left out of all these though was popular sportscaster and journalist, Kwabena Yeboah.

Yeboah left Accra for London last Monday to witness the FA Cup tie between Liverpool and Arsenal.

It may perhaps come as a relief to him that he was not here to witness the frightening spectre of bodies strewn everywhere at the 37 Military Hospital morgue. He returns on Friday.

Now that there is positive change in the country, I strongly believe that it will affect my darling club and people will see the emergence of a new Asante Kotoko and they will be greatly marvelled.



There is no doubt that there was some level of vandalism at the stadium, but it never deteriorated into direct confrontation between the two supporter groups. Indeed the atmosphere of camaraderie that existed last Wednesday between the two supporter groups was worthy of commen-

It is thus unfortunate and irresponsible for some misguided elements to try and point fingers at Kotoko.

It is in the same vein that we are saddened by reports that a donation made by Hearts of Oak late last week was specifically meant to go to victims who had Hearts of Oak sympathies. Hearts have reportedly recapitulated but most of the major news media picked up the unfortunate codicil to the donation and we must say that it was a most unfortunate comment.

It seems some people with Hearts of Oak sympathies are trying their best to accuse Kotoko of causing the disaster because it was when their fans threw chairs that the police reacted by firing teargas.

This is no time to point accusing fingers, and it is imperative that such inflammatory thought processes be nipped in the bud before they manifest in actions that will further shock an already stupefied nation.

If pointing fingers was something to create waves over, then perhaps we could easily say those few Kotoko supporters were only taking a cue from their Hearts of Oak colleagues who thought them how to destroy chairs when they lost to Kotoko in the Guinness Gala final. One action

Ghana mourns stadium victims

he President, Mr. John **Agyekum** Kufuor has stressed the importance of not dispensing with the services of the police for failing to function properly on a number of occasions.

Since last Wednesday there have been widespread condemnation of the police for causing the death of 126 able-bodied Ghanaians who

paid a minimum of ¢10,000 to watch a league match between Accra Hearts of Oak and Kumasi Asante Kotoko. With the police service now reeling under immense credibility pressure, the military has found favour with the people.

At the Abossey Okai Central Mosque where the muslim casualties were laid in state before burial last Friday, angry youth chased away

some police men who had come with the view to maintaining order amidst chants of "we want soldier, we want soldier".

But the president has advised that despite their punctured and badly damaged image, what the police service needs is transformation and reinvigoration to enable it meet societal needs and expectations. While calling on the public to exercise maximum restraint during the period of mourning to allow the proper process for the identification and punishment of all those found responsible to take place, Kufuor also advised the public, especially, members of the bereaved families to consider it important to reject any fringe elements that will seek to politicise the tragedy.

He said the anger which the tragedy has inflicted on Ghana is justifiable since the enormity of the castatrophe is too much for mere mortals to comprehend.

The president was speaking at a National Service ceremony held at the Open Court at the State house in memory of the victims of the tragedy and also to end the three

days of national mourning he declared last Thursday following the event.


In a statement that underscores his call for the rejection of people who might want to exploit the mood prevailing in the country at the moment to stir up divisive tendencies, Kufuor said, " this nation has come through many trying episodes and when we have triumphed, it has been because we have stood together as one peo-

At this crucial time, the president stated that the nation needs to cultivate a sense of unity, fellowship and human solidarity to overcome this national predicament. He remarked, " that is our tradition, that is our way of doing things. And there is no reason to abandon such a vir-

Otumfuo who made a cash donation of 20 million cedis to the victims also called for national unity during these trying times. He has meanwhile suspended his trip indefinitely.





Kumasi laments stadium disaster



he beautiful game of football is meant to bring unity and friend-liness among people through FAIR PLAY. But the unity and friendliness that was to be derived from the game rather brought pain and sorrow to the entire country as a result of police over-zealousness.

Some members of the public in Kumasi have reacted at the national disaster, which is now referred to as Black Wednesday.

JUSTICE ADDO (TAILOR. ASH-TOWN) - It is good that the President has advised us not to pass judgment at the moment but I had long ago anticipated something of this nature, though not to such alarming proportions, because of the way our referees have in most cases handled some matches with bizarre decisions. Violence should never be endorsed in anyway but I think there is a level of patience of human beings. The issue of referees' appointment must be seriously looked at.

With the police I think they simply take delight in firing teargas. They acted rather callously. Their penchant for firing teargas is quite on the high. As the President has promised, offenders must be dealt with after the Presidential enquiry. To our people who are bereaved I would want to take this opportunity to express my profound condolences. I pray for quick recovery for the



injured and to the departed, may the good Lord grant them a peaceful rest.

AKOSUA FREMPOMAA – It is very sad for Ghana to lose as many as 126 human lives because of football. It is terrible but I hope that the culprits would be brought to book after the Commission of Enquiry set up by the President has finished with their work and would hope again that they be dealt with according to the dictates of the law.

The arrival of the new administration has witnessed a number of shake-ups in the various sectors of the country but not in sports. I think there is a lot of rot in the sports sector, which I believe government should take a critical look at. We voted for them because we needed "positive change" and we are eager to see the change!

To the police, they better be up and doing. I wish the

HENRY ADUBOFOUR – So far I know one person called Sani who lives at Bantama who is reported dead. Apart from him I do not know any other person who died.

I attribute the disaster to poor officiating. If what people who watched the match are saying is anything to go by, then obviously the blame should go to the referee and his assistants.

They showed open bias against Kotoko to the extent that even before the kick off fans foresaw the calamity that was imminent since he had proved his bias against Kotoko on previous occasions.

sions. Virtually all the infringements were against Kotoko and this was enough to prove to all and sundry that they were to make sure that Hearts beat Kotoko at all costs. Had it not been poor officiating I don't' think such a nasty incident would have occurred in the first place since it was at the same venue last year that Kotoko lost 0-4 to Hearts. No nasty incident was recorded then because no one had qualms with the level of offici-



ating.

Something seriously has to be done about the manner and quality of referees appointed to handle such matches. Sometimes it looks as if the appointments committee has no regard for the level of passion involved in matches between these two sides. Well, this is the time for them to review their practices.

MADAM CECILIA ANANE -

I will squarely put the blame on the referee. If it was true that the Assistant Referee's flag was up and the referee ignored it and allowed Hearts to score then I have no doubt in my mind that it was the referee who sparked off that nasty incident at the stadium.

I will also blame inconsistency on the part of the football authorities as another cause of the disaster because they allowed the clubs to hold them to ransom by rejecting one referee after the other. Such inconsistency is unprofessional.

Naturally since Kotoko had previously rejected the one who was eventually selected there was no way he could have favoured the visiting team.

Even though it is not right for a supporter to visit his anger about poor officiating on state property, considering the behaviour of spectators worldwide, there was nothing anyone could do to prevent such spontaneity.

After all the plastic chairs are not more valuable than



human life and it is here that the role the police played comes into focus.

If they knew that teargas canisters were used to disperse crowds they should not have used it in an enclosed area like the stands at the stadium. The police are there to protect life and property and if they have failed to do so then they should be punished for their irresponsible action.

As a member of the GFA when we meet what I will put across is that the police should be well educated about the role they should play in such situations. They should also be re-trained in crowd violence situations so that there will be no repetition of the Accra stadium disaster.

I am urging the bereaved families to take heart and commit all that happened to the Almighty God and for the injured I wish them speedy recovery.

ANTHONY BOADI MOORE

- I wish to express my sorrow and shock at the tragedy. It is really painful for human lives to be substituted for plastic chairs. It is quite incomprehensible but adhering to the advise of the President we will not pass judgment.

However I believe we must get to the drawing board and re-assess the architectural design of the stadium. I believe that if we had had a lot more exits the situation would not have been that disastrous.

On the issue of the police I think their inability to assert themselves for over 20 years has accounted for their lack of potency in the handling of such situations.

I suggest that the government apportion some of the budgetary allocation for arms and ammunition to safety and disaster management equipment.

To the injured I pray for their quick recovery. I console the bereaved families.

ALHAJI YAHAYA — Right from the word go the referee did not hide his intention of favouring Hearts. He interacted freely with the Hearts side but the same could not be said of the Kotoko side and this heightened supporters' apprehension that they would not be treated fairly. For the "Positive Change" message to be realized there

would not be treated fairly. For the "Positive Change" message to be realized there should be a major shake-up at the GFA leadership. Agra, Ampem Darko and Laryea, the man who has been appointing referees should all go since their positions have been compromised.

Virtually all the top sports gurus are Hearts sympathizers and they have chosen not to be neutral and objective.

For the victims of the disaster

all that I can say is that they died as martyrs especially for Kotoko and I can assure them that Kotoko will capture the league trophy to honour them.

JOSEPH E. SAMPSON -

The scale of the disaster is too great to recount. It has never happened in the annals of the country's political history. May the dead rest in perfect peace.

I blame poor and bias officiating as the root cause of the disaster.

In such tension-packed matches between two sides any indiscretion on the part of the referee was bound to spark off trouble and possible mayhem.

For some time now Hearts has been beating Kotoko and that jinx had to be broken at all cost thus the tension was high. The referee marred the beauty of the game when he ignored the assistant referee's flag and set the stage



for spectator agitation.

The way and manner the police on duty at the time reacted to the spectators' behaviour is something not to be glossed over since they are not well trained and equipped to contain such situations.

A typical example was the teargas incident during the Hearts-Esperance match in Accra last December, which forced CAF to sanction Ghana, but it appears we did not learn from the incident.

If one watches other international matches it is clear that truncheons are used to contain crowd violence.

The police should use teargas canisters sparingly so that they can save lives. Police personnel who will be detailed to provide security at league centres should be adequately trained and this will go a long way to forestall such unfortunate situations.

I will like to stress that pentup feelings amongst soccer fans will always be expressed irrespective of the consequences and no one can suppress it, so long as referees continue to behave irresponsibly on the field of play.



OSEI KOFI – I put the blame on the police, the Sports Council and the referee who handled the match since in my opinion none of them played their role or roles effectively. I think if any one of them had behaved responsibly in the execution of their jobs the incident would not have occurred in the first place.

The reason why I am saying this is very simple. If the referee had played his role well the crowd would not have responded violently. If the police had also realized that they were there to protect lives they would not have fired the teargas.

There is no doubt that matches between the two sides are always characterized by tension, therefore the moment fans of one side realize that their team is being given a raw deal, they begin to react negatively.

On the other hand if the two sides realize that everything is fair, everybody accepts the outcome.

I know Hearts had beaten Kotoko several times in the past but I see this defeat as a result of poor officiating so I am really disappointed by the outcome.

For the dead, all that I can say is they should rest in peace. To the bereaved families they should also accept my condolences and to the injured I wish them speedy recovery.
